


Notice of Modification

SCHEDULE 2

1. In the Minister's determination, delete all text and replace with the following:
I, the Minister for Planning, under the *Environmental Planning and Assessment Act 1979* determine to approve the concept plan referred to in Schedule 1, subject to the conditions in Schedule 2.
2. In Schedule 1:
 - i) delete the descriptions for "Land", "Proposal", "Major Project", "Concept Plan Authorisation" and "Critical Infrastructure" and insert the following:
