# Determination of Modification Application MLC Senior School Centre (SSD 6484 MOD 1)

Thank you for your Department's letter received on 7 March 2017 referring the above modification application to the Planning Assessment Commission (Commission) for determination under Ministerial delegation of 14 September 2011. Lynelle Briggs AO, Chair of the Commission, nominated Abigail Goldberg (as chair) and Garry West to constitute the Commission to determine the application.

Methodist Ladies College (Applicant) seeks to modify the development consent for the approved redevelopment of its campus in Park Road and Grantham Street, Burwood. The proposed modifications would:

- increase the height of the approved Teaching and Learning Building from three storeys to four storeys;
- delete the approved additions to the year six building and Sutton wing; and
- increase the gross floor area (GFA) across the school site by 862 square metres (m<sup>2</sup>).

As part of the consideration of this modification the Commission has been briefed by the Department, met with Burwood Council and the Applicant, and conducted a site inspection. Minutes of these meetings are attached at **Appendix A**. The Commission notes that both the Applicant and the Department subsequently clarified floor space calculations for the proposed modifications as detailed below.

The Commission notes that the proposed modifications would allow for the co-location of science and language areas, and additional facilities for the history as well as science, technology, engineering and maths (STEM) faculties, and a staff room. The modifications provide for collaborative learning spaces in line with current pedagogical trends, and for the replacement of older class rooms. The modifications do not increase the number of classrooms overall at the school, nor is an increase in the number of students or teachers accommodated at the school proposed.

The Commission has considered carefully the Department's assessment report, the information provided by the Applicant, recommendations from government agencies and section 96(2) of *Environmental Planning and Assessment Act 1979* (EP&A Act).

Key matters for this modification are highlighted by Burwood Council's objection to the application. They include whether the modifications comply with section 96(2) of the EP&A Act, compatibility with the zone objectives in the *Burwood Local Environmental Plan 2012*, and building height, setback and floor space issues.

The Commission has reviewed the Department's assessment of these matters and is satisfied with the Department's recommendations. In particular, the Commission is satisfied that the modifications are within the scope of section 96(2) of the EP&A Act, despite Council's concerns. In this regard, the character and intensity of the proposed use remains the same, while the additional height (1 storey) and floor space (862m² or 7.5%) are relatively minor and would not result in additional amenity impacts.

The Commission accepts the Department's evaluation of the zone objectives for the land. While zoned for low-density residential uses, the (long established) use is for education purposes. In light of the existing built character of the site, and the approved development, it would not be appropriate to argue that the buildings should now have a low density residential character. The Commission also notes the Department is satisfied that the modification is consistent with the design principles in *Draft State Environmental Planning Policy (Educational Establishments and Child Care Facilities) 2017*.

Finally, the Commission accepts the Department's assessment of built form issues. In particular, the Commission notes that the additional overshadowing does not affect private property and that visual impacts are not significant owing to the additional storey being seamlessly integrated in with the existing approved building. The Commission notes that the boundary setbacks have already been approved, and, incidentally, allow for additional ground level green spaces to be created within the school site.

For the reasons set out above, the Commission accepts the Department's recommendation that this proposal be approved. Consequently, the Commission has determined to approve the modification application subject to the conditions set out in the draft instrument of approval.
