Thank you for the opportunity to speak. I can only once again voice my opposition and request the proposal is not approved at this time on the following grounds

- The proposal should be rejected as it is a "farm", as it is unlike any other farm. It is an industrial development proposing now ? 84 monstrous structures on a height we haven't yet seen
- A height of 137-158 metres (one and half times the size of those on the Cullerin Range)
- The environmental destruction guised as ancillary infrastructure and road "upgrades largely to get these monsters onto virgin bush land.
- We will be one of those "overlooked residences in the intermediate precinct predicted to have high impact with no less than 18, 137 metre monstrosities generating, what will it be 8.5mV or 300mV ???, all less than 3 km from our residence. "Rockview" Lot 118 Pudman Lane Blakeney Creek see attachment below with map extract from the development proposal.
- We have had NO consultation with any of the companies Epuron, Trust,
 Tilt, Rye Park Wind Farm who next...., despite trying to contact them.
- 254 hectares of native vegetation over 26 kms, mostly ridgeland, mostly ancient friable rock/soils, this doesn't include the native vegetation along some 200kms of roadways that will need to be cleared
- The proposal is deemed to be for efficiently using the regions significant wind resources. It seems the significance of this natural environment is "insignificant" to the greed to develop what will become a folly, a misguided belief of helping to reduce greenhouse gas emissions. The environment will benefit us more left in its current state.
- The industrial development has had multiple owners testament to the
 commitment of the proponent, a commitment only to achieve approval
 in any form. Once approved the whatever "strict conditions" imposed
 will have no meaning with further proponent name changes who will
 later apply for changes to these strict conditions, and build what they
 want. The rugged hills will be one of sweeping blades, however little
 power output will be produced.
- The Australian energy Market Operator (AEMO), the body corporate responsible for the administration and operation of the wholesale national electricity market in June 2016 reported "flat forecasts for energy consumption in the 20 year outlook to 2035." Largely due to the


