Re: Determination of 75W Modification (MP_090028 MOD 3) and a State Significant Development Application (SSD 8169) North Byron Parklands Cultural Events Site

Thank you for your letter dated 19 December 2018 about the Aboriginal cultural heritage assessment and consultation undertaken to inform the proposed modification and State Significant Development proposals seeking comments from the Office of Environment and Heritage (OEH). I appreciate the opportunity to provide input.

The OEH has reviewed the documentation provided and all sources of information available to us and provides the following comments in relation to the three (3) queries raised by the Commission Panel's correspondence for your consideration:

- 1. A current search of the OEH Aboriginal Heritage Information Management System database returns eight (8) registered Aboriginal sites within the North Byron Parklands project boundary. These sites are not expected to be impacted by the proposal.
- 2. The minimum consultation with Aboriginal people that is required in accordance with current OEH policies and procedures depends on whether the proposal is a new or an existing/ongoing matter. The OEH considers that the ongoing involvement of Aboriginal knowledge-holders through the Arakwal Aboriginal Corporation and the Tweed Byron Local Aboriginal Land Council in all matters relating to Aboriginal cultural heritage assessment and management for the North Byron Parklands proposal accords with current OEH policies and procedures.
- 3. The OEH "Due Diligence" policies and procedures do not require any consultation with Aboriginal people if the proposal does not require regulation under an Aboriginal Heritage Impact Permit.

The OEH is unable respond to the Panel Commission's invitation to provide comment on the wider claims to cosmic and global significance presented at the public meeting, as the Powerpoint presentation forwarded with the request has no visible content to view to inform our response.
