# **RE – Vickery Extension Project**

To Whom it may concern;

I'm writing on behalf of the Whitehaven Coal - Vickery extension public hearing in which I was unable to attend due to illness.

I support the Vickery Extension project and would like to convey my reasons for this determination to the commission. The following points are a brief on this position;

# Economic Development and Sustainability

The Gunnedah shire has, for many years endured through drought and hardship for various reasons including the closure of the local abattoir. To this point, mining has diversified the area away from the reliance on farming and associated industries to provide a stable foundation for jobs, investment and migration to the area. Mining has therefore contributed to the survival and development of not only the Gunnedah area but, the wider area's including Tamworth and Narrabri.

Sustainability of this sector (pillared by the Vickery extension project) will continue the support of local areas and provide jobs for the future of the towns kids who currently leave to pursue their dreams in other places closer to stable employment opportunities.
