Please be advised that to my great disappointment I will be unable to attend tomorrows meeting at Rooty Hill RSL due to a family emergency. I was hoping to get someone else to read my notes but am unsure if this would even be acceptable by the council given the short notice.

We have so very much going for Blacktown with such a diversity of people and opportunities. My question is WHY would we jeopardise this with an Incinerator.

We have at least 158 schools in the area. The census of people living in Blacktown in 2016 was 336,962 living in 110,903 dwellings

Blacktown Council has a \$600 million upgrade planner for the CBD.

Blacktown Hospital is still being developed to be on par with Westmead.

We have numerous attractions surrounding Blacktown such as the Eastern Creek Raceway, Featherdale Wildlife Park, Wet N Wild Theme Park , Nurragingy Reserve, The Blacktown Arts Centre and many wonderful sport fields and the Blacktown Showground.

Why on earth would we put any of this under direct fire and within a short distance to an incinerator of the size being proposed??

Blacktown is becoming a place to visit especially with the planned open plains zoo under construction plus. Rooty Hill RSL is building a \$100 million state of the Art Theatre. Would people still visit if our pollution levels become potentially dangerous to both them and their children due to this incinerator?.

With an ever growing population and increase in construction in the area we are fast causing too much pollution ourselves without any added by an incinerator that will eventually burn more than a million tonnes of waste a year – right across the M4 from Minchinbury to Eastern Creek.

The effects of this incinerator to residents will be permanent and immovable if it is allowed to be built.
