I have been fighting the Moorebank Intermodals for 9-10 years. During this time I have spent countless hours of my time putting together submissions and taking time off work to present to NSW PAC as the chance to make these presentations is always during normal office hours. I have been forced to become somewhat a minor expert in areas that I am not trained in nor wish to become expert in. The result of all this time and hard work has been very little. The intermodals are charging ahead regardless of what the residents have presented in the past.

Unfortunately, it seems that smaller local companies that pose far less threat that try to relocate in an attempt to expand don't get the same leniency as the intermodals. These smaller companies would have provided far more employment per square metre and far more benefits for the community than the intermodals and are far less harmful to the surrounding areas.
