The attached signatories who are all Narrabri Shire locals, mostly retired or semi-retired, and who have no pecuniary interest in the project, have requested I write to your Commission conveying our deep concern that the extent of community support for the Narrabri Gas Project has been grossly misrepresented.

The assertions, by opponents to the project, that there is majority community opposition, is in our opinion, totally false.

Our belief not only relies on our unanimous support for the project, but on the feedback from the many local community members with whom we have regular contact.

It would appear to us that the the opposition has relied on a fear campaign, which commenced years ago.

Firstly, by focusing attention on the perceived danger from "fracking", by hosting a screening of the film "Gasland", and an activist speaker from the USA. This early and ongoing assertion of damage to ground water quality through chemical contamination has had a continuing negative influence on community attitudes, not withstanding "fracking" is not contemplated.

Secondly, of the people the signatories have spoken to, particularly those who are still in business, many are not prepared to publicly offer their support due to fear of reprisals. In a small community, this concern is very real; not only for fear of damage to their livelihood, but also to their standing in the community and harm to lifelong friendships.

We urge you to approve the Santos project based on scientific information, not on fear.
