Thanks for your time earlier.

As discussed, the Commission has received a referral from the Department to give advice on the Gateway Determination Review Request for the heritage listing of 149 Livingstone Avenue, Pymble.

We have received a comment from a community member stating that Andreana Kennedy, Council's Heritage Officer changed her recommendation on 17 September 2019 to a recommendation supporting the heritage listing.
