To ICPN re Hume Coal Project and Berrima Rail Project (SSD 7172 & SSD7171).

Dear Sir / Madam

Mr Jon and Mrs Voni Leighton of [REDACTED], Sutton Forest 2577 (email address, [REDACTED]) have made a submission to the ICPN in relation to the above project.

As their neighbour and resident of [REDACTED], since 2001, they have kindly asked, after reading it, if I would like to add my name to their submission, to which I have agreed. There is one thing that I would like to add is the case of noise and vibration generated by the mining underground. The depth in some places, if I remember reading correctly, is only 70 metres, if not shallower, from the surface and my place of residence is near some of that area.

I am sure from your own experiences that you would be well aware that noise in country areas travels for great distances due to the quietness and I am afraid that will be the case in this instance especially when they use explosives, at night time, to access the coal. In regards to the vibration created either by explosives and the type of machinery used my house is built on piers and thus is susceptible to movement caused in the substructure which could lead to significant damage.

Having spoken to a resident of Helensburgh, 2508, who attended one of the meetings held at Mossvale RSL, I was informed that he and his family were woken by explosions, in the early hours of the morning, from the mine. I and I'm sure my neighbours do not want to go through the same scenario, as we have settled here to enjoy the attributes of "country life" Please take note of these concerns in your assessment as I and my neighbours live here full time, not Hume Coal.
