I believe the proposed Regis Resources gold mine at McPhillamy's is a positive development for the Blayney area. The Blayney area, and the Central West Region, has long been associated with mining activity, for gold, copper, and other basemetals. Right from the earliest days of settlement, mining and agriculture were the mainstays of economic development in the area, and for Australia in general.

I firmly believe that this should still be the case – agriculture and mining should be complementary, not adversarial - too many people seem to think the latter. Farmers need what miners produce, and miners need what farmers produce. Farmers might not use gold directly, but they benefit from the economic activity that gold mining generates, in the same way that the local population benefits. Australia as a whole also benefits from gold production, when government distributes taxes and royalties back into the community as public facilities, transport infrastructure, community services, and so on.

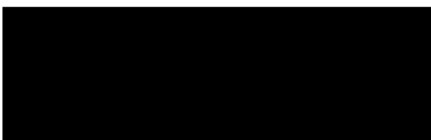
I also feel very positive about the way that most Australian mining companies themselves these days make a big effort to contribute to, and improve, the local communities that they work in. I see contributions to education, recreational facilities, community organisations, and the environment, apart from the provision of jobs and training opportunities for the local population.

Yes, mining does have an effect on the landscape, and so does agriculture. Most of the natural environment has long gone in this area, but mining has only been associated with a small percentage of that change. I know personally there is a big focus these days on land and landscape rehabilitation after mining – ask some of the younger people in town if they can identify the site of the B -Y gold mine which was right on the edge of Blayney !! Or drive up Browns Creek Road and see if you can spot the gold and copper mine which operated up there for 20 years in recent times. I expect in 20 year's time that the McPhillamy's mine site and tailings facilities will be equally unobtrusive.

Farming and mining are both subject to government regulation, and mining particularly so. Regulation for both is never perfect, but I do believe that the mining regulations can effectively allow for successful mining activity with minimal negative impacts on the local community. This is achieved through monitoring of noise, dust, water quality, and regular review of all mining aspects.

I live within two kilometres of the proposed McPhillamy's site. I have found that Regis are good communicators, very informative about their plans, and genuinely concerned about effects on my property, particularly natural water resources. I welcome positive developments in the area, having lived here for over 30 years, and I believe the McPhillamy's mine will be one of them.
