Thanks for this. We are currently progressing the responses however are unlikely to have everything ready by Monday 4th March. Are we please able to get a 1-week extension until 11th March?

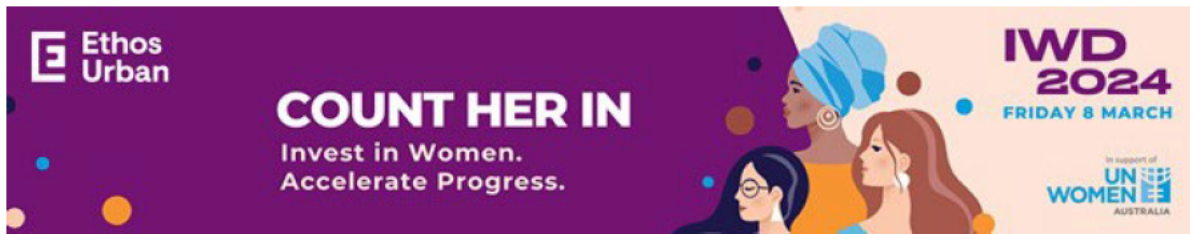
