Dear IPCN,

There are numerous problems associated with the Dubbo Firming Power Station (SSD-28088034) - including the Conflict of Interest of IPCN panelist Mr Andrew Mills - where "Mr Mills has disclosed that his self-managed superannuation fund holds shares in a company that has an owner in common with the corporate parent of the applicant for this matter" - in this case the very controversial Twiggy Forrest!

Whilst Mr Mills & the IPC claim that "To the best of Mr Mills's knowledge and that of the Commission, the outcome of the present matter has no reasonable likelihood (and Mr Mills has no expectation) of financial loss or gain to Mr Mills or the company in which Mr Mills's fund owns shares.

On that basis, Mr Mills in his capacity as Chair of the Commission has decided that no actual, perceived or potential conflict of interest arises that prevents him from forming part of the present Panel."

This is a totally inadequate & unacceptable self assessment & judgement.

Whilst the Fake Green RenewaBULL Solar/Wind Energy Poverty Grift & Ponzi Scheme/Scam is based on lies & deceit & littered with self benefiting vested interest decisions & Conflicts of Interests that are NOT FOR THE GREATER GOOD, it's well past time that the Government's ruinous RenewaBULL plans are properly scrutinised by the most credible, independent experts who have integrity & ethics that are beyond question & suspicion.

It is also highly inappropriate that multi Billionnaire Twiggy Forrest should be squandering Australian Taxpayer funded subsidies on his own financially lucrative propaganda & ideological crusade that includes such a foolish, impractical & implausible Hydrogen Generation Plant

Additionally, the Australian Energy Infrastructure Commissioner Andrew Dyer has advised a Central West community to commence a Class Action against Squadron Energy regarding their grossly unacceptable Spicers Creek Wind Neighbour Agreements, which is hardly a recommendation for any further activities - including this controversial, greedy, self serving Squadron Energy Hydrogen fantasy!

With irresponsible, careless developments such as Squadrons, approved by the NSW/Australian Government - they are *not* meeting Australian and International Standards with these environmentally ruinous RenewaBULL plans:-
AS/NZS ISO/IEC 17021.2:2013 [ISO/IEC TS 17021-2 :2012] *Conformity assessment - Requirements for bodies providing audit and certification of management systems. Part 2: Competence requirements for auditing and certification of environmental management systems*

AS/NZS ISO/IEC 17021.2:2013 Clause 6.7 regarding **Use of Space/Physical Attributes (Clause 6.7)**

Requires knowledge of:

- a. **the interactions of the physical attributes (size, shape and colour) of buildings, structures and equipment with the local environment (eg, man-made structures that detract from natural ambience, nature, flora and fauna, and natural settings of the environment in which they have been placed);**
- b. **Operational controls and techniques to manage physical attributes, such as planning and design, landscaping, use of colour to reduce intrusive impact on the environment; and**
- c. **the monitoring of spatial planning, building and equipment requirements as well as maintenance systems and landscaping**

‘Green hydrogen’ gas production requires two main ingredients: (a) A lot of water - eighteen to one ratio and (b) More electricity input than hydrogen energy output – five to four ratio.

These are two commodities that the Central West/Australia has precious little of, that will be squandered with the Dubbo Hydrogen Production plan.

This plan is based on the RenewaBULL Swindle which is already imploding globally & unjustly denying Australians our own far superior, reliable, affordable, secure, natural energy resources!

Availability of Results.
