The development supports ageing in place, with adaptable care and services aligned with the Royal Commission into Aged Care recommendations.

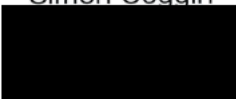
Environmental design principles focus on net zero emissions, energy efficiency, and habitat protection.

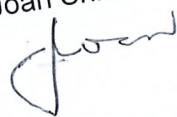

Residents will benefit from dignified, person-centred care that allows them to age in place, while the site's renewal ensures long-term community support.

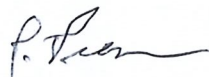

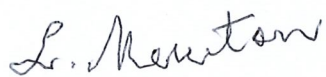

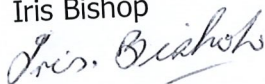
