#### **EXECUTIVE SUMMARY**

#### INTRODUCTION

Catholic Metropolitan Cemeteries Trust (CMCT) has prepared a masterplan for a proposed new cemetery at 166-176 St Andrews Road, Varroville, called Macarthur Memorial Park.

Urbis was engaged by CMCT to undertake community consultation to inform the development of the masterplan and Development Application. This report documents the consultation process, community feedback, and considerations in response to community feedback.

#### **CONSULTATION PROCESS**

Community consultation was undertaken over 6 weeks in June and July 2017. Consultation activities included:

- Distribution of a letter and project fact sheet to 1,600 households, stakeholders and previous submitters notifying them of the proposed DA, community information and feedback sessions and contact details for further information.
- Two Community Information and Feedback Sessions (three hours each) attended by approximately 41 people.
- Formal feedback forms available at the Community Information and Feedback Sessions
- A project website including copies of all materials distributed and displayed at the Community Information and Feedback Sessions.
- Additional feedback channels including a dedicated project email, 1800 phone number and online feedback forms.
- A meeting as requested by three stakeholders who responded to the letter distributed to the local community.

#### **COMMUNITY FEEDBACK**

Feedback received during the consultation process were generally either supportive (14 feedback forms) or not supportive (12 feedback forms), with no middle ground. The feedback was often not in response to specific aspects of the masterplan, but expressed as being for or against the proposed land use as a cemetery.

Other themes raised in feedback were:

#### **Planning Process**

- Opposition to the September 2016 JRPP decision to allow a cemetery as a permissible land use on the site, continues to affect how some regard the draft master plan for the site.
- There is distrust in the planning and decision making process, particularly regarding the role of State Government and decision making bodies who did not support the views of Council.
- There is a level of distrust regarding the Catholic Metropolitan Cemeteries Trust.

#### **Traffic**

- There is a general concern about existing traffic congestion on St Andrews Road.
- There are concerns regarding the poor condition of St Andrews Road and its future ability to support additional traffic.
- The draft master plan needs to show site access off St Andrews Road and parking provision across the site more clearly.
- There is support for St Andrews Road to be improved and upgraded as part of the draft master plan.

#### **Scenic Hills**

- There is a strong desire to preserve the Scenic Hills for its heritage values, ecology and natural amenity. Based on this, many are opposed to any form of development occurring in this region.
- There are concerns that approval of development application will pave the way for future development in the Scenic Hills region.

#### **Draft Master Plan and Design**

 There is support for the overall vision of the draft master plan including the landscape design, open space and recreational facilities.

A summary of all feedback is outlined in Section 3.2 of this report.

#### **CONSIDERATION OF FEEDBACK**

The project team have been provided with detailed notes of all feedback received during the community consultation process. This has also been reviewed in project meetings.

- Road design and layout, visual impact, access and parking, landscape design and sculptural design and locations have been further considered in the review of the draft master plan and technical investigations. Specific responses are outlined in the Statement of Environmental Effects accompanying the development application.
- Archaeological investigations of Aboriginal heritage have continued, and will be reviewed in consultation with Traditional Owners.
- A review of the draft master plan will be undertaken against the requirements of the Conservation Management Plan prior to finalisation and lodgement of the development application.

#### CONCLUSION


All community feedback received during the consultation process has been summarised in this report and provided to the Project Team for their consideration. This report will also be submitted to Campbelltown Council with the Development Application.

#### 1. INTRODUCTION

Catholic Metropolitan Cemeteries Trust (CMCT) has prepared a masterplan for a proposed new cemetery at 166-176 St Andrews Road, Varroville, called Macarthur Memorial Park. Figure 1 shows an aerial view of the development site (the site).

Urbis was engaged by CMCT to undertake community consultation to inform the development of the masterplan and Development Application.

#### 1.1. THIS REPORT

This report documents the consultation process, community feedback, and considerations in response to community feedback.

This report has been provided to the Macarthur Memorial Park project team to help inform their ongoing prior to submission of a Development Application to the Campbelltown City Council.

The report will also be submitted to the Campbelltown City Council as part of the detailed Development Application.

#### **CONSULTATION PROCESS** 2.

#### 2.1. PURPOSE OF CONSULTATION

The community consultation process for Macarthur Memorial Park aimed to:

- Provide information about the draft master plan and the process to prepare the development application.
- Invite feedback through a range of channels, to inform ongoing design and planning.
- Collate feedback and prepare a summary of consultation outcomes.
- Inform the finalisation of the draft master plan and the preparation of the development application for lodgement.

#### 2.2. **OVERVIEW OF ACTIVITIES**

Community consultation was undertaken over 6 weeks in June and July 2017. Consultation activities included:

- Distribution of a letter and project fact sheet to 1,600 households, stakeholders and previous submitters notifying them of the proposed DA, community information and feedback sessions and contact details for further information.
- Two Community Information and Feedback Sessions (three hours each) attended by approximately 41 people.
- Formal feedback forms available at the Community Information and Feedback Sessions
- A project website including copies of all materials distributed and displayed at the Community Information and Feedback Sessions.
- Additional feedback channels including a dedicated project email, 1800 phone number and online feedback forms.
- A meeting as requested by three stakeholders who responded to the letter distributed to the local community.

#### 2.3. LETTER TO RESIDENTS AND FACTSHEET

A letter and project factsheet was distributed on 7th and 8th June 2017 to approximately 1600 neighbouring residences, to notify them of the proposed development and upcoming consultation activities. A copy of the distribution catchment can be found Appendix A.

The letter also advertised an opportunity to meet with the Project Team at the upcoming Community Information and Feedback Sessions. See Appendix B for a copy of the project fact sheet.

#### 7.4. PUBLIC ADVERTISEMENT

An advertisement detailing the Community Information and Feedback Sessions was placed in the Macarthur Chronicle and Macarthur Advertiser for distribution in the week from the 12th – 16th of June 2017.

A copy of the advertisement can be found in Appendix C.

#### 2.5. STAKEHOLDER BRIEFINGS

A letter or email was sent to local stakeholders and previous submitters on Wednesday 7th of June 2017 offering an opportunity to meet with members of the Project Team. It included the project factsheet and advertised the upcoming Community and Information Feedback Sessions.

Stakeholders included:

City of Campbelltown Councillors.

- State Labour MPs.
- Community groups.
- Neighbouring properties.
- Previous submitters.

#### 2.6. MEETING WITH NEIGHBOURING PROPERTIES

Three neighbours to the site took up the offer to meet with Susan Rudland (Community Consultation) and Cameron Nixon (Urban Planner) on 21 June 2017 at the Campbelltown Catholic Club.

Participants at the meeting were provided an A3 colour copy if the information boards and feedback forms to be displayed at the community information and feedback sessions.

Key issues discussed included:

- The role and purpose of the consultation process at this time.
- The use and validity of consultation outcomes, if it is not based on the final development application.
- The planning and development application process.
- The need for the final master plan to align with the Conservation Management Plan and amended LEP.
- The basis for the application, and the ownership status of the site.
- The importance of greater clarity in labelling, definitions, illustrations and plans.
- The design and materials for the road network.
- The nature of proposed parking provision.
- The Local Heritage curtilage and permitted activities.
- Impacts on views, vistas, heritage landscape and fauna.
- Retention and treatment of dams and waterholes.
- Safety and security.
- Noise and lighting impacts.
- Privacy and property value impacts.
- Upcoming community information and feedback sessions.

Following the meeting, participants emailed with further questions and clarifications regarding the purpose of the meeting, the use of consultation outcomes, the consistency of information provided, access points off St Andrews Road, and when fully detailed final plans and supporting information would be available.

It was also requested that Council extend the Public Exhibition period to at least 3 months (not including mid-December to end January) to allow the community to examine all information and seek advice as required.

#### **COMMUNITY INFORMATION AND FEEDBACK SESSIONS** 2.7.

The Community Information and Feedback Sessions were held on Thursday 22nd and Saturday 24th June at the Campbelltown Catholic Club, 20-22 Camden Road, Campbelltown. Each session was conducted over 3 hours.

- The opportunity to speak directly with members of the Project Team.

#### 2.7.2. Feedback

At each session, feedback was invited via:

- Feedback forms and reply paid envelopes (see Appendix E).
- Online feedback forms on the project website.
- Members of the Project Team were briefed to note down the key issues and questions raised during discussions, and these were collated and reviewed after each session.

The feedback received is documented in Section 3.2 of this report.

#### 2.8. MACARTHUR MEMORIAL PARK WEBSITE

A copy of the information boards displayed at the Community Information and Feedback Sessions were uploaded to the project website (www.mmpark.com.au/local-community) so the information was available broadly. The feedback forms distributed at the Community Information and Feedback Sessions were also made available to download from the project website.

#### SUMMARY OF FEEDBACK 3.

#### 3.1. COMMUNITY FEEDBACK

Twenty-six feedback forms were received at the time of writing. Feedback was generally either supportive (14) or not supportive (12), with no middle ground. The feedback was often not in response to specific aspects of the masterplan, but expressed as being for or against the proposed land use as a cemetery.

Other key themes raised in feedback were:

The project team have been provided with detailed notes of all feedback received during the community consultation process. This has also been reviewed in project meetings.

Specific responses are outlined in the Statement of Environmental Effects accompanying the development application.
- Archaeological investigations of Aboriginal heritage have continued, and will be reviewed in consultation with Traditional Owners.
- A review of the draft master plan will be undertaken against the requirements of the Conservation Management Plan prior to finalisation and lodgement of the development application.

#### 4. CONCLUSION

This report has summarised feedback received during community consultation regarding the draft master plan undertaken in June and July 2017.

Community consultation was conducted to invite feedback on the draft master plan to date, and to inform ongoing planning and design for the preparation of the development application. Information outlined work in progress.

All community feedback received to date is summarised in this report and provided to the Project Team for their consideration.

This report will also be submitted to Campbelltown Council with the Development Application.

Overall, there were clear views expressed during community consultation, both for and against the draft master plan.

These views appear to be influenced by differing perspectives, between those who opposed the decision of the JRPP in September 2016 to allow a cometary as a permitted use on the site, and those who see an identified need for a new cemetery in the region.

Specific feedback on aspects of the draft master plan have been considered, specifically in relation to the importance of clear and detailed information in the final development application, options to review the design and layout of the road network and parking provision, and heritage, landscape and amenity impacts.



• 35.5 hectares of publicly accessible parkland including walkways, sculpture park and picnic areas.

#### **Buildings and facilities**

 Six new buildings to accommodate cemetery and recreational uses, including a multidenominational chapel, cemetery function room, café and workshop.

#### Heritage

- Restoration of existing historic buildings for public use
- Expanded heritage curtilage around Varro Ville Homestead
- A 'no build area' restricted to development as a lawn cemetery to protect the visual landscape.

#### Parking and access

- Vehicle and pedestrian access via St Andrews Road
- Construction of internal roads, pathways and approximately 280 parking spaces.

#### Planning process

The DA follows the decision in September 2016, by the Joint Regional Planning Panel, to include *cemetery* as a permitted use on the land at Varroville.

As part of the DA, a range of technical studies, including heritage, traffic and visual assessments are being undertaken.

Once the DA is completed, it will be lodged with Campbelltown Council and placed on public exhibition. Due to the significance of the project, the consent authority will be the Sydney South West Planning Panel.

#### Parklands and public art

 35.5 hectares of publicly accessible parkland including walkways, sculpture park, including 34 artworks and picnic areas.

#### **Buildings and facilities**

 Six new buildings to accommodate cemetery and recreational uses, including a multidenominational chapel, function room, café and workshop.

#### Parking and access

- Vehicle and pedestrian access via St Andrews Road
- Construction of internal roads, pathways and approximately 280 parking spaces.



## Staging of Development

The development of the cemetery will happen over many years, slowly extending the cemetery in stages.


The northern half of the site (north of Varroville House) is expected to reach capacity in approximately 110 years and the full cemetery will reach capacity in approximately 150 years.

## Stage 1

Stage 1 will have the largest footprint and include:

- Chapel, mortuary, function building and associated carpark
- Ground staff facilities, administration office, café gatehouse facility and associated carparks
- Entrances and roads within stage 1 area

- Outbuildings restoration works, keeping existing road for access.
- The rest of site remains unchanged.
- This stage will provide burial for approximately 85 years.





## The Planning Process

#### Planning proposal approved

September 2016

CMCT submitted a planning proposal to allow cemetery as a permitted use for this site only.

The Joint Regional Planning Panel approved this change and it was included in the Campbelltown Local Environment Plan.

## **Preparation of the Development Application (DA)**

**June 2017** 

CMCT is preparing a DA for the entire site for use as a cemetery and parklands.

As part of the DA a range of studies and community consultation is being undertaken.

All feedback received will be considered by the project team before the DA is submitted

#### DA submitted for assessment

July/August 2017

Once finalised and feedback has been considered, CMCT will submit the application to Campbelltown City Council for assessment.

#### Public Exhibition of the DA

Minimum 28 days

The DA will be placed on public exhibition for 28 days. All submissions received will be reviewed and considered.

## **Decision by Sydney South West Planning Panel**

Late 2017

Due to the capital investment value of project (approximately \$40 million), the consent authority will be the Sydney South West Planning Panel, following assessment by Campbelltown City Council.

## Campbelltown Local Environment Plan

Local Environmental Plans (LEPs) are legal instruments prepared by Council to guide planning decisions and ensure local development is appropriate.

7.8A of the Campbelltown LEP outlines the site-specific conditions that apply to the site of the proposed Macarthur Memorial Park.

## Landscape Masterplan

A landscape masterplan has been prepared for the entire site by Florence Jaquet Landscape Architect.

This concept is based on the belief that a cemetery can be a park, a sanctuary, a sculpture park and open space available to all. It is also based on the belief that the landscape concept should respect and respond to the site-specific constraints.


### The vision

The landscape plan vision is to provide:

- Burial space that offers choice, at affordable prices, in varied settings, for a multi-denominational community
- A distinctive landscaped cemetery, the best of its kind, the pride of the industry
- A sculpture park, offering opportunities for local and Australian artists
- A respectful space and scenic route, open to all
- A cemetery which respects and safe keeps the important colonial and noncolonial landscape
- An arboretum for future preservation and education of generations to come
- A concept which respects the land, its landform and ecology by carefully laying roads and any built environment and limiting their "footprint"
- Concealed, private and low laying burial spaces to minimise visual impact

## Heritage

The Macarthur Memorial Park site has played an important role in the history of NSW.

## Aboriginal Heritage

Macarthur Memorial Park is situated near the border of both the Darug and Gandangara language groups.

Several Aboriginal heritage investigations of Macarthur Memorial Park have been completed, including consultation with the Tharawal Local Aboriginal Land Council and the Cubbitch Barta Native Title Claimants Aboriginal Corporation. Investigations have identified 29 sites within the study area with ranging archaeological sensitivity. Further studies are being completed.

#### Heritage protection and restoration

It is acknowledged that a cemetery will require alterations to the Varroville Estate. The proposed works will be undertaken in a way that is sensitive to the rural landscape and significant heritage character of the place.

To protect and restore the heritage of the site the following initiatives have been proposed:

- Expanded State Heritage Register curtilage around Varroville Homestead acknowledging the significance of cultural landscape
- Restoration of the heritage listed outbuildings within the Macarthur Memorial Park site for public use as an Education Centre, relating to the site's rich Aboriginal and European Heritage
- A 'no build area' restricted to development as a lawn cemetery to protect the visual landscape
- Retention of part of the existing well-preserved vineyard contour trenches and partial reinstatement of vineyards
- Interpretation of the original carriageway

## European Heritage

The site of the Macarthur Memorial Park, forms part of the original Varroville Estate (c.1810) which comprised 1,000 acres granted by Governor Macquarie to Dr Robert Townson, the first European land owner.

Varroville House is a substantial single storey residence (not part of the Macarthur Memorial Park site) which was established in 1858-59 and contains heritage significance at a State level. The Macarthur Memorial Park site however includes significant aspects of the cultural landscape associated with Varroville House, including outbuildlings (timber slab hut, cottage, and former coach house) early carriageway, remnant vineyard contour trenching and dams.

Part of the chain of dams some of which have been attributed to the occupancy of Charles Sturt (late 1830's)

## Traffic, Access and Parking


## The Macarthur Memorial Park will include:

- 4 access points via St Andrews Road
- Access A connecting with Road 1 will be the main site access
- Approximately 280 formal parking spaces to service the Chapel and other buildings
- Additional parallel parking adjacent to the burial rooms throughout the site
- A road network to provide access between buildings, parkland and burial areas
- Walking trail network throughout the site

### Traffic assessment

A traffic and parking assessment has been completed by The Transport Planning Partnership. Key findings include:

- There are sufficient internal car parking spaces and kerbside parking spaces to provide excellent parking provision for people wanting to park alongside graves
- The road network has sufficient capacity to accommodate the expected traffic volumes including the additional traffic associated with the proposed development
- Overall there will be no adverse traffic and parking implications associated with the proposal.
