I am writing in reply to your email to the Environment Protection Authority (EPA) dated 18 June 2018 seeking comments on the above modification application. The proposed modification seeks to extend the duration of the demolition period by ten months (until 10 June 2019) due to delays associated with the removal of butane infrastructure on the site.

The letter prepared by AECOM Australia dated 15 June 2018 states that over the past 18 months Caltex have been investigating options for the potential retention and reuse of the butane assets at the Kurnell Terminal site. Following a detailed internal review, Caltex has decided not to retain any of the butane assets at the site and intends to demolish these assets as originally consented under MOD 1 to SSD 5544.

Based on a review of the information provided and taking into consideration the existing approval conditions for the conversion project (SSD 5544 MOD 1), Caltex should continue to undertake the proposed demolition activities in accordance with the Demolition Environmental Management Plan and associated sub-plans. Caltex must ensure that all identified management and mitigation measures identified in these plans are implemented effectively to minimise any potential offsite impacts.

The EPA also advises that no amendments to Caltex's Environment Protection Licence (EPL 837) are required as a result of the proposed extension of time.
