

Traffic and Transport

The DP&E Assessment Report concluded:

- A history of continuous improvement;
- The successful hosting of SITG18 (with 35,000 patrons), which met all traffic KPIs;
- Recommended the continuation of the existing traffic KPIs; and
- The RMS supported the proposal with a staged increase in patron numbers.



Noise Performance



Noise

The DP&E Assessment Report concluded:

- Suitable noise limits are in place across the community;
- The C-weighted low frequencies are now regulated; and
- The applicant has continuously improved and refined its noise management regime.

Wastewater

- Parklands propose to design the system to meet stringent effluent quality performance criteria recommended by GHD;
- Parklands has worked with GHD and BSC to refine its wastewater treatment system and irrigation scheme;
- The Dept, together with GHD have developed a suite of conditions to ensure minimal impacts;

Wastewater

- "The Dept supports the Applicant's commitment to design a wastewater treatment system capable of meeting the proposed effluent quality performance criteria";
- Parklands also has two licensed liquid waste treatment facilities who have agreed to accept all liquid wastewater on an ongoing basis if required;
- No liquid wastewater needs be sent to BSC.



Event Days

- Parklands has hosted 11 events to date;
- Parklands has operated 44 event days over the 1,958 days of the trial period;
- Parklands has revised the number of event days being sought after feedback from a number of onsite community consultation meetings as follows:

Event Size

- The Dept recommends a staged increase for the large winter event (SITG);
- Parklands is required to demonstrate compliance with KPIs via a Performance Evaluation Report before increasing patrons;
- The Dept has evaluated matters such as social impacts, public safety and crowd management and biodiversity and concludes they can be adequately managed subject to conditions

Department's Conclusions

- The impacts of the development can be mitigated and/or managed to ensure an acceptable level of environmental performance;
- The Department has concluded that with the Parklands' proposed mitigation measures, in addition to the Dept's recommended conditions, the site can continue operating with minimal impact upon the environment.
