As a concerned citizen living in Singleton shire I wish to register my dismay and disgust at the clearly corrupted process that resulted in this "determination" being released more than two hours before final submissions on air quality and other impacts closed. The unfortunate citizens who live with the effects of ever-expanding open-cut coal mines are forced to live with deteriorating health and the prospect of shortened life expectancy simply for the benefit of a few jobs and Royalties (plus political donations) to the State government. It is quite plain that the invited submissions were not considered nor ever intended to be.
