- My background and relationship with the company:
 - 2007-present: Plant Operator who works directly in the Rixs Creek South operation.
 - Family work for the company.
- My role as Rixs Creek lodge secretary:
 - ➤ I have a direct relationship with the 249 members who are employed with Bloomfield as operators, fitters and electricians.
 - ➤ 181 of these members live in close proximity of the mine in the Singleton, Muswellbrook, Cessnock and Maitland shires.
 - ➤ I have a unique perspective of the socioeconomic impact the uncertainty of this project has had on these members.
- Bloomfield Group Foundation and Rixs Creek Lodge charity work:
 - Contribution to charities, schools, sporting teams, festivals, country shows.
 - ➤ Rixs Creek Lodge will often donate to the same causes. Recent examples include, ourcare services, buyabale.com and the Atkins family. These are for local causes, which is a good reflection on the company, when the local community is hurting or in need we will always be there.
 - ➤ I received an email from Danny Eather from the Westpac Rescue Helicopter to acknowledge Bloomfield Group employees had contributed \$23,953 in 2018/19. The Rixs Creek Lodge will also be the gold sponsor for the Rixs Creek Rattlesnakes rugby league side that will compete in the charity day in October.

- Conditions of Consent: Part B Specific Environmental Conditions:
 - My role as a plant operator at the Rixs Creek South operation and why I am best placed to highlight how we walk the walk too.
 - Air Quality: Identifying the hazard and how we control the hazard Digger Faces, haul roads, drill patterns, monitoring wind speeds.
 - ➤ Noise: Trigger Action Response Plan to manage complaints and high noise levels during monitoring.

Noise monitoring personnel review predictive 3D noise model and meteorological conditions for any potential for Rixs Creek to exceed compliance limits.

When noise levels exceed compliance levels we amend operations in conjunction with the feedback we receive.
