Thanks for the email.

The client has reviewed the submission made by the department and wishes to make the following comments in respect to the substrate issue and the solar panels for the rooves.

The comments are below

Fresh Substrate will be delivered inside the proposed building via the "filling/transfer corridor" with walking floor trailers, the substrate will be filled directly into the multi-level growing shelves along the northern boundary.

Spent Substrate is emptied through external hatches along the southern building (Third Flush growing rooms) where it is conveyored directly into trucks and delivered to an off site location and/or, will upon completion of Stages 2-5 be transferred to the spent storage building located on the western side of the main building. The spent compost storage will be used to dry compost before it is sold. The spent compost storage building will be an enclosed structure to protect it from rainfall.

Point 5

The current application involves and seeks to approve solar panels on the north facing rooves.
