Thank you for giving me the opportunity to read Mr O'Donoghue's letter of 22/7/21 ref. IRF21/2957 providing the commission with additional information related to the Hume Coal Project and Berrima Rail Project.

Mr O'Donoghue's rightfully describes the Southern Highlands shire as an area where:

1. "historical coal mining in the Berrima region was generally small scale with the Berrima Colliery now in closure stage"

And

2. "The region is now more widely known for its rural land uses, small-scale agriculture, scenic landscapes and tourism".

Based on the above, I urge the Independent Planning Commission of NSW to look further than a short term mining project which will perhaps bring 300 temporary jobs in the area (if their numbers are correct) but will also jeopardise the creation of long term jobs in the agriculture, the food and wine, the hospitality and tourism industries. These sectors are arguably the fastest growing in the area and have a large potential of growth particularly since the closure of Australian borders during the Covid pandemic has given millions of Australians the healthy habit of visiting and enjoying their own backyard.

The Southern Highlands have seen the highest number of tourists during the past year, it would be a real setback for the whole tourism industry if the Hume Coal Project was to go ahead as it would tarnish the reputation of the highlands as an area of rural land uses, small-scale agriculture and scenic landscapes. Who would respond well to the area marketing itself to potential visitors as "the home of a new coal mining project"?

I do believe that the opening of a new coal mine is in direct conflict with the interest of the food and wine and the hospitality and tourism industries and since the later do not have the same uncertainty, short life prediction and negative side effects on the local environment and the people living in the

area, I urge the Independent Planning Commission of NSW to reject the mining project.

Lastly, isn't it time that governmental planning commissions take at heart their responsibility to reduce Australia's contribution to global warming and promote industries that are sustainable on both an environmental and economic development points of view?

Recommending against the Hume Coal project would be a great step forward in that direction.
