Request for Gateway determination review (GR-2022-31) – Planning proposal to amend the planning controls for land at 13-27 Riddell Street and 14-15 Buller Street, Bellevue Hill (PP-2022-1663)

I am writing to advise that the Department of Planning and Environment (the Department) has received a Gateway determination review request from Woollahra Municipal Council (Council) for the above planning proposal. Details of the planning proposal are summarised below:

	decreasing the maximum height of building standard for the subject properties from 10.5m to 9.5m; and
	 decreasing the minimum lot size standard for the subject properties from 700m² to 675m².

Council is seeking a review of the Gateway determination issued by the Department on 17 October 2022, which determined that the planning proposal should not proceed.

The Commission is requested to review the planning proposal and prepare advice concerning the merits of the review request. The advice should include a clear and concise recommendation to the Minister's delegate confirming whether, in its opinion, the Gateway determination should be altered.
