#### LOCATIONS AND KEY OBSERVATIONS

### 1) Reception

Panel Chair opening statement and introductions.

#### 2) Junior School

The Panel observed the existing Junior School Building located to the north east of the proposed Project area. The Applicant advised that they intended to redevelop the Junior School in the future.

### Centenary Car Park

The Panel observed the existing car park. The Applicant confirmed that parking, access and pick-up/drop-off would continue to be managed via their management plans. The Panel observed the interface between the Aquatic Centre and the sports field located above the car park.

## 4) Gymnasium and Goodlet House

The Panel observed the interface between the existing gymnasium and the Project area. The Panel observed Goodlet House which is located due north of the Project area.

### 5) Grey House Precinct

The Panel observed the area and Project boundary for the proposed redevelopment. The Panel observed the interface between the Project and the surrounding buildings. The Applicant pointed out the vegetation proposed to be removed. The Applicant pointed out the indicative building setback locations. The Panel observed the interface between the PLC campus and the residential area to the south/south-east. The location of adjacent dwellings and Grey House Walk was observed by the Panel.

### 6) Proposed Construction Access

The Panel observed the proposed construction access and the southern site boundary. The site boundary and interface with the adjacent golf course was visible. Existing sporting facilities and the PLC agricultural plot was viewed by the Panel. The Site Inspection concluded at Reception.
